### 4. **TERMS AND CONDITIONS**

## **Entering**

1. The entrant must be an Alumni from the JB Marks Education Trust Fund
2. The entrant must be over the age of 18 (eighteen) at the time of the Alumni Game Changer Awards, unless otherwise stipulated.
3. The entrant must submit all documents as per the checklist.
4. The deadline for entries is stated on the Alumni Game Changer Awards promotional material. Late entries will not be accepted.
5. The JB Marks Education Trust Fund reserves the right to verify any information provided by the entrant.
6. The JB Marks Education Trust Fund reserves the right to limit the number of entries made by an entrant.
7. Current members of the JB Marks Alumni Executive or staff of the JB Marks Education Trust Fund should not be nominated
8. The nomination process is confidential, an entrant will not be given the details of the individual who nominated them. A candidate can nominate themselves.

## **Judging Process**

9. The outcome of the Alumni Game Changer Awards is subject to the decision of the Awards Committee appointed for the various judging rounds, and their decision is final.
10. An Awards Committee member is not eligible to enter, nor to judge the entry of an organisation in which he or she may be involved in any capacity.
11. The right remains within the Awards Committee to change the category in which the entrant entered.

## **Winners and Finalists**

12. Winners and finalists will be announced at the Annual JB Marks Alumni Awards on 23 August 2019 at Emperors Palace.
13. JB Marks Education Trust Fund shall be entitled to publish information and photographs of the winners and finalists, on its website, in its publications and in promotional material, without liability on the part of JB Marks Education Trust Fund (including remuneration for the use of such material).
14. Should JB Marks Education Trust Fund decide to issue prizes and/or framed certificates, and should these not be claimed within 30 (thirty) days of the prize-winner being announced, the prize-winner forfeits the prize and JB Marks Education Trust Fund reserves the right to re-award or dispose of the prize.
15. Prizes may not be exchanged for cash or any other prize, nor are they transferable.
16. JB Marks Education Trust Fund reserves the right to re-award any prize to another finalist in any category should the winner be disqualified for non-compliance with these terms and conditions at any time.
17. Finalists and winners will make themselves available for future road shows and/or interviews during their reign as winner or finalist.
18. Finalists and winners agree to be interviewed by the media.
19. JB Marks Education Trust Fund reserves the right to withdraw any prize/recognition at any time should a winner or finalist become involved in any corporate malfeasance.
